**1. Prioritization Resolution (Discussion/Action)**

*a. Resolution text: "Courses and programs are addressed in technical review and reach curriculum committee meetings in the order in which they (or revisions thereof) are submitted to CourseLeaf. In limited, rare, and documented circumstances, exceptions may be made to this process by the co-chairs or technical reviewers if there is pressing reason to do so (i.e., changes to state mandates, etc.). Any such alteration in prioritization will be reported at the next Curriculum*

meeting. Any other changes to the prioritization of classes/programs must first come to CC for discussion and a vote. The only other way to alter the location of a course/program on the prioritization list is for the course author (and dean if applicable) to request a time-certain at technical review. Courses and programs are addressed in technical review and reach curriculum committee meetings in the order in which they (or revisions thereof) are received. Exceptions to this general rule may be made as follows:

- In limited, rare, and documented circumstances, (e.g., changes to state mandates, etc.), which will be reported to Curriculum Committee at the next meeting
- A course/program author (and/or associated department chair/dean as warranted) may request a time-certain at technical review

Any other changes to the prioritization of classes/programs must first come to Curriculum Committee for discussion and a vote.”

**D. Proposed Distance Education Resolution (Discussion/Action – 5 minutes)  
– M. Werness-Rude, P. Sezzi**

1. *Resolution text: “As there is no longer any meaningful distinction between the 0-50%, 51-99% and 100% DE modalities at the state level, any course at Ventura College that has any of the three permanent DE modalities selected will henceforth be considered available to offer in all DE modalities. As courses move through Curriculum from this moment on, DE availability in any modality will be indicated by simply selecting the 100% DE modality box (to facilitate this process and ensure consistency across curricula moving forward, if any DE modality box is selected, technical reviewers will check the 100% box and add the requisite DE boilerplate statements to that section).”*

*M. Werness-Rude called for a motion to approve the Distance Education Resolution*

*Discussion: There is no meaningful distinction in DE modalities at the state, but distinction is becoming an issue locally, and has been compounded by emergency pandemic situation we are currently facing.*

*Changing CIM to just one box would be very extensive as it serves all 3 colleges in the district. This is an easier workaround.*

*Discussion to amended motion to say if one box for DE is checked, the technical reviewers will check all 3 boxes to cover the bases as a better way to show all DE is available for use. This will cover any course with DE selected in it.*

*Concern that a new policy like this would come as a surprise to disciplines/departments who have chosen a DE selection for philosophical reasons. Should we take this to the departments first before a vote?*

*This resolution is intended just for the Technical Reviewer group. This will not affect the integrity of the course. Instruction in DE modality will still be decided by the department.*
